1. Customers taking an All Rounder plan on or after 29 August 2024 can choose Google One Premium 2TB as the Inclusive Extra available on their plan ("**Google One Premium 2TB Inclusive Extra**") for no extra charge. Customers taking a Full Works plan on or after 29 August 2024 can choose Google One Premium AI as the Inclusive Extra available on their plan ("**Google One AI Premium Inclusive Extra**") for no extra charge. The Google One Premium 2TB Inclusive Extra and Google One AI Premium Inclusive Extra is not available to customers on an All Rounder plan or Full Works plan taken before 29 August 2024.
2. **The Google One Premium 2TB Inclusive Extra** is an individual membership and gives access to 2TB of storage for Google Photos, Drive, and Gmail. It also includes additional benefits such as access to Fitbit Premium and Nest Aware (**the "Google One Premium 2TB Services"**). The **Google One AI Premium Inclusive Extra** is an individual membership and gives access to 2TB of storage for Google Photos, Drive and Gmail. It also includes additional benefits such as access to Gemini Advanced, Fitbit Premium and Nest Aware. (**the "Google One AI Premium Services"**). Access to the range and content of additional benefits within the Google One Premium 2TB Services and Google One Premium AI Services may change at any time.
3. You will need to activate your Google One membership by completing the activation process. You will receive instructions on how to activate the Google service via a text message. The Google Premium Services and Google AI Premium Services will start as soon as we accept your request for activation. We therefore advise you to complete activation of your Google One membership immediately.
4. Data used whilst using the **Google One Premium 2TB Services** and **Google One AI Premium Services** will be deducted from your EE Price Plan's inclusive data allowance.
5. As soon as the **Google One Premium 2TB Inclusive Extra** or **Google One AI Premium Inclusive Extra** is removed from your account, your access to the **Google One Premium 2TB Services** and **Google One AI Premium Services** will cease.
6. The **Google One Premium 2TB Inclusive Extra** or **Google One AI Premium Inclusive Extra** is provided to you as an Additional Service. As an **Additional Service** it does not form part of your Price Plan with us. We'll refer to it as an Inclusive Extra in MyEE, on your bill, online and when you call or text customer services.
7. Before requesting this Additional Service, you must acknowledge and understand that any change to the cost of, or content included as part of the membership upgrade do not entitle you to cancel your Agreement with us for mobile network services.
8. When entering into a contract for digital content you're entitled to a 14-day cooling off period, except where you enter into a contract in store. Once you've entered into a contract for these Additional Services, you'll have 14 days to tell us you've changed your mind. However, once you've accessed Google One (e.g. by using the services) we'll assume that you've decided to waive this right to change your mind and you'll lose your right to cancel, except in accordance with the cancellation process described above.
9. We may suspend access to or terminate your contract for the Additional Services if you fail to pay a bill by the date set out on it or commit another material breach of your Agreement for mobile network services (visit [here](#) to read the latest version of our terms and conditions).
