- The Competition is open to parents and/or guardians with children between the ages of 13-17, who are residents of the United Kingdom.
- 2. This Competition is not open to employees of BT Group (BT, EE, Plusnet or Openreach) and BAFTA, their families or its agencies. Only one entry per person.
- 3. EE reserves the right to verify the validity of entries (including an entrant's identity, place of residence and social media content) and to disqualify any entrant who tampers with the entry process or has contravened these terms and conditions.
- 4. Entries must be submitted via TikTok using the stitch Function. Entrants must stitch the relevant post on EE's TikTok account (@EE), with a video performance as a villain no longer than 1 minute, using the hashtag #eethestageisyours
- 5. Entries must be submitted by the TikTok account owner of a parent, legal guardian or responsible adult.
- The competition opens Monday 12<sup>th</sup> February and closes on Sunday 25<sup>th</sup> February at 5pm. Entries submitted after this date will not be considered.
- The winner will be contacted on or before 31<sup>st</sup> March by direct message from the EE Social team. If EE receives no response within 24 hours of contact, they have the right to contact another suitable candidate.
- 8. Entries will be judged on creativity, entertainment and best use of the AR (Augmented Reality) Film set filters. Entries will be judged by a Jury panel from the film industry.
- 9. Entries must be free from inappropriate language and must follow Instagram's community guidelines. Any entries that abuse the community guidelines will be discounted.
- 10. Once the winner has accepted the prize the EE social team will request an email address and contact number so that their agency MC Saatchi can follow up with further communications, itinerary for the day and prize details.

- 11. The prize is to have a small role in the film 'Naz', which will be shot between October November 2024. The role within the film is at the discretion of the promoter and date is subject to change.
