



TERMS & CONDITIONS

SIGNED FOOTBALL SHIRT PRIZE DRAW

DATE: 3 July 2025

1. The prize draw for signed football shirts from Home Nations teams (the “Prize Draw”) is open to UK residents aged 18 or over at the time of entry.
2. The Promoter reserves the right to verify the eligibility of entrants and check their identity (including an entrant's place of residence) and to disqualify any entrant who tampers with the entry process.
3. The prizes in the Prize Draw are 8 signed football shirts (together, the “Prizes”). The Prizes will be signed by players in Home Nations squads between June – July 2025 (the “Signing Period”). The specific Prizes are as follows:
 - 2 x signed England Women’s National team shirts
 - 2 x signed Scotland Women’s National team shirts
 - 2 x signed Wales Women’s National team shirts
 - 2 x signed Northern Ireland Women’s National team shirts
4. The Prizes are not recommended to be worn and should be used for display purposes only. Therefore, The Promotor cannot guarantee that the Prizes will be supplied in a size that is suitable for the Winner to wear.
5. The Football Association (a company with registered office address at Wembley Stadium, Wembley, London, HA9 0WS, incorporated under company number 00077797) reserves the right to determine which football teams, and players from these teams, will be signing the Prizes. Prizes need not be signed by every football player playing in the Signing Period, as this is subject to (a) The Football Association’s discretion and (b) attendance of football teams/players in commercial signing events. For the avoidance of doubt, (i) Prizes need not be identical or signed by the same football players, nor (ii) do they need to be signed by any or all of the football players used in marketing materials.
6. The Promoter reserves the right to in exceptional circumstances to vary, amend or withdraw this Prize Draw on reasonable notice. The Promoter can, at its discretion, withdraw the Prize(s) or the Winner (as defined in clause 10) if, in the Promoter's reasonable opinion, it is deemed necessary or if circumstances arise outside of the Promoter's control. The Prize must be taken as stated and no compensation will be payable if the Winner is unable to use the Prize.
7. To enter the Prize Draw, entrants would need to fill out and submit the entry form on the landing page¹. As part of this entry form, entrants will need to select one of their preferred Home Nations teams. Entries sent in through agents or third parties will not be entered into the Prize Draw. Entries cannot be re-submitted or amended.

8. The entry form can only be submitted once per person. Each submission will be treated as one entry into the Prize Draw. Entries of customers who have valid and concurrent EE Broadband and EE Mobile plans registered to the same EE account and EE ID (“EE One Customers”)² will be counted as having two entries into the Prize Draw. EE One Customers need not submit the entry form twice as this will be automatically calculated once their status as an EE One Customer has been verified by the Promoter. If the Promoter cannot verify an entrant’s status as an EE One Customer, their submission will be treated as one entry, subject to clause 2.
9. The Prize Draw opens on 07 July 2025 at 00:00 BST and will cease accepting entries on 31 July 2025 at 23:59 BST.
10. From 1 August 2025, entrants will be put into four (4) categories, depending on which Home Nations team they selected upon submission of their entry form (the “Categories”). There will be one (1) draw for each Category. These four (4) draws will take place on 4 August 2025. During each draw, seven (7) entrants from each Category will be randomly selected by a third-party agency, using an automated software, from all valid entries received (the “Winners”). The Winners will be allocated one Prize, from their respective category, each.
11. All entrants that were not selected as Winners during either of the four (4) draws will be pooled into a general non-Winner list (the “Pool”). In the event that one of the Categories contains six (6) or fewer entrants, once the list of entrants in that Category has been exhausted (in accordance with clause 10), the remainder of the Prizes can be allocated to entrants from the Pool, using the same procedure as outlined in clause 10. These additional entrants selected from the Pool will be deemed Winners in the ordinary sense.
12. The Winners will be notified of their selection by email at least seven (7) days after the Prize Draw closes but no later than 22 August 2025, using the contact details given upon entry. This notification will (i) state that they are a Winner, (ii) which Prize they have been allocated, and (iii) provide instructions on how to claim the Prize. Winners will receive their prize on or before 29 August 2025, subject to any logistical delays outside of the Promoter’s control.
13. The Promoter reserves the right to re-draw the Winner(s) if they cannot be contacted within five (5) days (to be established at the promoter’s sole discretion) and the right to disqualify any entrant or select alternative Winner in the event that it believes that any entrant has contravened these Terms and Conditions. The right to re-draw shall be conducted in accordance with clauses 10 and 11 above.

14. The Promoter may pass on Winners' contact details to a third-party provider to arrange fulfilment of the prize who will provide further details about the prize.
15. All entries must be the independent and original creation of the entrant and must not infringe the copyright or other intellectual property rights of any third party.
16. Entry into this promotion is dependent on your acceptance of these Terms and Conditions and by entering you confirm your acceptance of these Terms and Conditions. The Promoter shall be entitled (but not obliged) to use any entries submitted under this Prize Draw in any form, for all purposes in all media (including without limitation) any goods or products manufactured by or on behalf of the Promoter.
17. No responsibility is accepted for entries lost, delayed, damaged, corrupted or mis-transmitted due to electronic errors, malfunctions or any other kind of technical error. The Promoter reserves the right to alter, amend or foreclose this Prize Draw without prior notice if unforeseen circumstances make this unavoidable.

Your personal details will be retained for the purpose of the Prize Draw and will not be processed for any other purpose, unless you choose or have chosen to receive information from the Promoter.
19. The Promoter accepts no responsibility for damage, loss, liabilities, injury or disappointment incurred or suffered by the Winners in entering this Prize Draw or accepting the Prize, except in the case of death or personal injury caused by the acts or omissions of us or our employees.
20. The Promoter does not claim any rights of ownership in your Prize Draw entry.
