TERMS AND CONDITIONS

DATE: 28 March 2025

- 1. The competition for EE Game Store vouchers (the "Prizes") in relation to the April 2025 release of the Call of Duty Verdansk Map (the "Prize Draw") is open to UK residents aged 18 or over at the time of entry, other than employees, contractors, agents or directors of BT Limited ("BT"), their families, relatives, or any other person associated with this Prize Draw.
- 2. The Promoter reserves the right to verify the eligibility of entrants and check their identity.
- 3. The Prizes are split into four separate groups: Tier 1 contains 30 Prizes of £150 each, Tier 2 contains 60 Prizes of £60 each, Tier 3 contains 60 Prizes of £35 each, and Tier 4 contains 50 Prizes of £15 each (together, the "Tiers").
- 4. The Promoter reserves the right to substitute a Prize of equivalent or greater value if this is necessary for reasons beyond its control.
- 5. To enter the Prize Draw, eligible entrants must (i) send a screenshot of their in-game K/D combat record in Call of Duty Black Ops 6, which clearly displays the K/D ratio, and (ii) include the word "Scoreboard" in their message to the EE Instagram account @EE via Direct Message (the "Entry"). Entries sent in through agents or third parties will not be entered into the competition. Only 1 Entry per person.
- 6. The Prize Draw opens on 29 March 2025 at 09:00 GMT and will cease accepting Entries on 30 March 2025 at 18:00 BST. 200 Entries will be randomly selected by an independent person on 31 March 2025 (the "Winners"). The Winners will then be listed in ascending order and allocated accordingly to the Tiers in clause 3, according to their K/D ratio.
- 7. Entrants of Winners will be notified of their random selection by Instagram Direct Message on or before 28 April 2025. This notification will (i) disclose the monetary value of the Prize they have been allocated, and (ii) provide instructions on how to claim the Prize electronically.
- 8. Each Prize will contain a unique code. These unique codes are only valid for orders made on EE Game Store (store.ee.co.uk/gaming) and are valid until 30 June 2025. Each Prize is non-transferable and non-exchangeable. The Prize must be taken as stated and no compensation will be payable if the winner is unable to use the Prize. Any attempt to sell, transfer or exchange any part of the Prize will result in the Prize being withdrawn by the Promoter and the Prize will be declared null and void.
- 9. Only one voucher code per order is allowed on EE Store and cannot be used in conjunction with any other voucher, discount promotion or employee discount.
- 10. Vouchers are one time use. If you do not use the full amount against your order, the balance will be lost.
